





- Missed Modifiers Common errors with -50, -59, -LT/RT impact reimbursement for multi-site procedures.
- Auth Failures High denial rates tied to SCS trials, RFA, or SI joint injections without proper documentation.
- Inaccurate Coding Missed codes for fluoroscopy, bilateral injections, or multi-level procedures reduce revenue.
- Patient Payment Gaps Inadequate collection at the time of service causes write-offs or bad debt.
- No Analytics Practices that don't track denials or A/R trends miss out on fast wins.


